This update reflects NOAA Fisheries final rule to designate the southern DPS of green sturgeon as threatened, effective July 6, 2006. Also, the table reflects the correct status of Central Valley fall and late fall-run Chinook salmon and the northern DPS of green sturgeon, which were removed from the candidate species list and placed on the Species of Concern list, effective April 15, 2004.
